PROCEDURAL MATTERS

Governors were made aware that Giles Bedloe will struggle to make future FGB meetings due to current work commitments. It was agreed in principle that he could become an Associate Governor with a Safeguarding focus once a replacement had been recruited.

STRATEGIC MATTERS - EFFECTIVE GOVERNANCE Head Teacher Report

Governors were advised there are 12 PPG children on roll which includes

8 x FSM

3 x Ever 6

0 x LAC

1 x Service

Governors noted an increase in children learning EAL (28 = 1/6 of the school). Governors asked that at next C&L meeting ,to help them better understand the extent of pupil needs, be presented with the stage of English acquisition of children learning EAL and a Venn Diagram to show what cross over there is when children have more than one potential additional need

Governors were advised the HTLA had resigned and recruitment has begun.

AB asked when fire drill was undertaken and was advised 14 Sept. AB to arrange to attend next fire drill with VA.

SDP Priorities 2017 / 18

Governors offered feedback on the draft SDP, developed by SLT with the support of an independent consultant:



- Governors requested the document offer a more strategic and ambitious set of priorities with SMART (Specific, Measurable, Agreed upon, Time based) developmental goals so that progress could be more clearly monitored as required by effective governance.
- Governors asked if day to day operational details should be in a strategic overview?
- Each priority would be improved by the addition of some context /rationale.
- Governors felt the document did not reflect what the school is actually doing or the school's strengths. The style suggested a school in a considerably weaker position than Moss Lane
- Document should include clearer indicators for success.

After an extensive and robust discussion, it was agreed the draft SDP required some alterations. A revised draft is to be circulated to all governors for comment and then a small working party (to be agreed) will meet to finalise the SDP in readiness for ratification at next FGB. EJ suggested the governors might benefit from meeting with the consultant to understand the current thinking on SDP.

DfE Updates

Governors discussed headlines from Hot Topics summary document.

Governors requested password for ASP.

Governors were all asked to book a visit to the school to see the curriculum in action.

Pay policy review tasked to AaT.

School Designation

EJ and AB fed back, and governors discussed, the key points from the recent Confederation Meeting where the formation of a Co-operative Trust was discussed and key questions answered by rep. of the Co-op Trust and by a SCC representative. EJ proposed that "Moss Lane should pursue the next stage in forming a Co-operative Trust with other local schools."

Governors all agreed to the proposal GB and DabI had indicated their support for the proposal in emails to the chair/clerk.

VA & EJ to further investigate implication of land ownership which may impact membership status e.g. founder or associate member.

Governors look forward to the benefits & opportunities identified as shared practise; shared resources; economies of scale; shared staff; teacher training program.

Governor Training & Visits

AB has booked onto H&S, New Governor Part 2 and Visiting Schools training. Governors were all encouraged to book relevant training to their strategic area and book in visits to the school during the next term.
