### Moss Lane School COVID-19 Protective Measures Risk Assessment 11th January 2022



Please find attached the COVID-19 risk assessment for Moss Lane schools that has been prepared in response to the Government's guidance for full opening. The measures set out in this risk assessment provide a framework for school leaders to put in place proportionate protective measures for pupils and staff. Moss Lane is open for all children. Any children who are isolating will remain at home and will learn remotely.

Public Health England know that the predominant new variant of coronavirus (COVID-19) is more transmissible however, PHE advice remains that the way to control this virus is with the system of controls, even with the current new variants. It will not spread as readily if we avoid close contact with others. Wash your hands, wear a mask (if and when necessary), keep your distance from others, and reduce social contact in line with guidance. It remains vital that these measures, along with enhanced environmental cleaning and ventilation, are practised stringently.

#### **Protective measures**

The country's move to Step 4 of the roadmap marked a new phase in the government's response to the pandemic, moving away from stringent restrictions on everyone's day-to-day lives, towards advising people on how to protect themselves and others, alongside targeted interventions to reduce risk. Many protective measures that have been in place in schools are now no longer required in normal circumstances. This risk assessment reflects these changes, setting out the protective measures which will remain in place.

#### **Future outbreak planning and Variants of Concern**

This Risk Assessment is to be read alongside the school's Outbreak Management Plan, which describes what it would do if children, pupils, students or staff test positive for COVID-19, or how the school would operate if it was advised to reintroduce any measures described in this document to help break chains of transmission. It is essential for the Outbreak Management Plan to be kept up-to-date and relevant to the school's unique setting, referencing the government's <a href="COVID-19">COVID-19</a> Contingency Framework and the <a href="Surrey County Council local outbreak control plan">Surrey County Council local outbreak control plan</a>.

This risk assessment sets out the additional protective measures which will be considered in the case of and for the duration of an outbreak i.e. if a specific threshold is met, as set out in the government's <u>COVID-19 Contingency Framework</u> and the school's Outbreak Management Plan. The additional measures are given in this risk assessment under separate headings: "*Temporary additional measures in the event of an outbreak*" and are shown in *italic* text.

Please note there may be some overlap with targeted Government guidance relating to Variants of Concern such as Omicron, notably regarding the temporary reintroduction of face coverings.

- Pupils in these schools will also wear a face covering when travelling on public transport and dedicated transport to and from school.
- It is not ordinarily expected for teachers to wear a face covering in the classroom if they are at the front of the class, to support education delivery, although the school will be sensitive to the needs of individual teachers.
- At Moss Lane face coverings are recommended to be worn by staff and adults (including visitors) when moving around in corridors and communal areas.
- Children at Moss Lane will not be asked to wear face coverings.
- The guidance acknowledges circumstances where people are not able to wear face coverings.
- Face coverings do not need to be worn by a person who is exempt or when outdoors.
- Schools, as employers, have a duty to comply with the Equality Act 2010 which includes making reasonable adjustments for disabled staff; and to make reasonable adjustments for disabled pupils, to support them to access education successfully. No pupil should be denied education on the grounds that they are not wearing a face covering.
- Transparent face coverings, which may assist communication with someone who relies on lip reading, clear sound or facial expression to communicate, can also be worn.
- Face visors or shields can be worn by those exempt from wearing a face covering but they are not an equivalent alternative in terms of source control of virus transmission. They should only be used after carrying out a risk assessment for the specific situation and should always be cleaned appropriately.

# Temporary additional measures in the event of an outbreak

- If a specific threshold in the Moss Lane's Outbreak Management Plan is met the following additional measures will be considered.
- Face coverings may temporarily be re-introduced in communal areas and classrooms for pupils (aged 11 and over), staff and visitors, unless exempt.
- Transparent face coverings, which may assist communication with someone who relies on lip reading, clear sound or facial expression to communicate, can also be worn.
- Face visors or shields can be worn by those exempt from wearing a face covering but they are not an equivalent alternative in terms of source control of virus transmission. They should only be used after carrying out a risk assessment for the specific situation and should always be cleaned appropriately.
- In the event of an outbreak, <u>Contingency</u> <u>framework: education and childcare settings</u> will be referred to in reimplementing the use of face coverings.








Day (1-10) self-isolation.



Lateral flow tests generally shouldn't be used for children under 5 years. Do not use lateral flow tests on anyone displaying symptoms.

Negative result



Anyone who tests positive will be able to leave self-isolation 7 days after the date of their initial positive test if they receive 2 negative lateral flow test results, 24 hours apart, on days 6 and 7. The first lateral flow test should not be taken before the sixth day. If any of these tests are positive, they should continue to self-isolate until day 10.

Anyone aged 5 years and over, who has been identified as a contact of someone with COVID-19 and who is not legally required to self-isolate, is now strongly advised to take a rapid lateral flow device (LFD) test every day for 7 days (or until 10 days since their last contact with the person who tested positive if this is earlier).

If you are aged over 18 years and 6 months and are not fully vaccinated and you have been informed by NHS Test and Trace that you are a contact of a person who has had a positive test, you are legally required to stay at home and self-isolate

Under 5s are exempt from self-isolation and do not need to take part in daily rapid lateral flow testing.



Return to early years/primary setting if child is well
